# Part A: Pupil premium strategy plan

## Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not. High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, we are in the final year of targeted support through the School Led Tutoring Programme for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

## Part B: Review of outcomes in the previous academic year

### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2023 to 2024 academic year.

Our internal assessments suggest that the performance of disadvantaged pupils needs to remain a focus.

As evidenced in schools across the country, school closure was most detrimental to our disadvantaged pupils, as they were not able to benefit from our pupil premium funded improvements to teaching and targeted interventions to the degree we had intended. The impact was mitigated by the additional funding given provided to schools in order to ensure pupils made rapid progress.

It has been pleasing to note that over the previous two years, pupil attainment and progress for our disadvantaged pupils has improved; however, this is an area which will continue to remain a focus. Pupils' social emotional and mental health will also remain a focus, as the proportion of pupils requiring this level of support is increasingly annually.

Attendance sits above the national average. However, at times when all pupils were expected to attend school, absence among disadvantaged pupils was marginally higher than their peers. This is why attendance is continually monitored and will remain a focus of our current plan.

Our assessments and observations indicated that pupil behaviour, wellbeing and mental health were significantly impacted primarily due to school closures. The impact was particularly acute for disadvantaged pupils. We used and continue to use pupil premium funding to provide wellbeing support for all pupils, and targeted interventions where required. We will further build on securing pupil progress and attainment in addition to promoting positive wellbeing approaches through the activities detailed in this plan.
